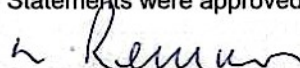

The internal audit for 2024/25 has been carried out in accordance with this authority's needs and planned coverage. 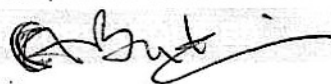
