1. **Parish Council Notes:**

- a. Further to previous announcements regarding a proposal for an **improved** Broadband service for Forthampton, Gigaclear have now agreed to include Forthampton and Chaceley in their Tirley fibre rollout which is scheduled to begin this Spring. Precise details are still to be defined and more information will be disseminated as it becomes available. In the meantime, it is important for everyone to register their interest in the roll-out by going to: https://www.gigaclear.com/postcode.co.uk/broadband.html
 - After entering your postcode and selecting your address from the drop-down list, you should find where to "Register Interest". If your address is not listed, please enter "not one of these" which will enable you to register your interest while reminding Gigaclear to update their lists of addresses.
- b. In response to the action in the Forthampton Parish Plan to introduce a small number of additional houses, discussions are underway with Tewkesbury Borough Council to arrange an on-site meeting with members of the TBC Planning Office to discuss options. This meeting should occur within the next few weeks, after which we should have a better understanding of the options and restrictions.
- c. The Corse & Staunton GP surgery has issued its Winter newsletter which is attached for information.
- d. The Tewkesbury CAMRA Winter Ales festival is to be held in Watson Hall (Barton Street) from 1st – 3rd February. The festival will feature 80 lovely winter ales together with freshly made, locally sources food at every session. Tickets cost £5, including souvenir mug (CAMRA members free).

The President opened the January meeting of the Forthampton & District WI by wishing everyone a Happy New Year and presenting buttonholes to those members whose birthdays occur in December and January. The guest speaker, John Holloway, gave a detailed and fascinating insight into the role of a JP, outlining the differences between a Magistrates' Court and the County Court. He spoke of the types of crime dealt with by each of the courts, the former dealing with minor offences and preliminary hearings for more serious offences, which will then be referred to the County Court. Whereas the County Court has a judge and jury, the Magistrates' Court has three magistrates (one Chairman and two wingers). Those present were somewhat amazed to learn that Cheltenham Magistrates' Court is the only one serving Gloucestershire. John explained that a number of very minor offences are now dealt with by the police, either by an on-the-spot fine or a verbal warning. Hence the number of defendants being referred to the Magistrates' Court has declined in recent years. John also outlined the process by which anyone can apply and be considered for the position as a JP. He concluded his presentation by setting up a role-play where members took part in the trial of an alleged shoplifter. The verdict was not as expected which leads to guestions as to whether our WI members would make good magistrates!
